The Participant hereby releases, waives, discharges, and relinquishes any action or causes of action for personal injury, property damage, or wrongful death, which may occur during any Training Sessions or any pursuit incidental thereto.

The Participant further agrees that under no circumstances will the Participant prosecute or present any claim against any member or person associated with Tri Doha LLC(G) (the “Tri Doha LLC(G) Persons“) for any causes of action, personal injury, property damage, or death, whether the same shall arise by the negligence or non-intentional conduct of any of the Tri Doha LLC(G) Persons during any Triathlon Activity or any pursuit incidental thereto.

The Participant hereby agrees to indemnify, saves and holds harmless each of the Tri Doha LLC(G) Persons from any loss, liability, damage or cost which the Tri Doha LLC(G) Persons may incur as a result of injury, death, or property damage to the Participant occurring during or incidental to any Training Sessions, or from any action from such personal injury, death, and/or property damage to the Participant.
